By signing this contract, the legal representative or parent/guardian confirms that the child is legally insured (health insurance, accident insurance, liability insurance). Insurance is therefore the responsibility of the parent/guardian. Furthermore, the legal representative grants small Foot AG the right to conduct external events as well as projects indoors and outdoors.

With this contract, small Foot AG confirms that the legally required insurance cover is in place (liability, business and legal protection insurance). The daycare centre must be notified in the case of absences of any kind (illnesses, accidents, holidays, etc.). There is no entitlement to compensation days or a reduced monthly fee.

The undersigned, as the child's legal representatives, confirm that they have been informed in detail about the daycare centre and the institution small Foot AG in a meeting with the daycare centre's management. They have received, read and acknowledged the concepts, fees and General Terms and Conditions pertaining to the Childcare Contract (GTC) and have agreed to all points.
