General Terms and Conditions at the Time of Contract Signing

Registration

Admission is granted irrespective of nationality, race, religion, or social status. A child's admission becomes definitive once the care contract is signed by the educational management or group leader and the parents. Parents must pay a deposit equivalent to one month's fee. Parents receiving subsidies from the Canton of Schwyz are exempt from the deposit payment if the municipality directly pays their share to us. A copy of the health insurance card must be submitted upon registration. The Zürisee-Kinderbetreuung concept is part of the care contract and governs the cooperation between the parents and Zürisee-Krippe GmbH.

Regular, Short-Term, and Flexible Care

Details about the various care options can be found in the child care concept under section 5.7.

Termination Notice

Either parents or Zürisee-Krippe GmbH can terminate the care place with a two-month written notice, during operational hours, by the end of each month. If the notice period is not adhered to, the full fees will be charged. If a care place has been contractually agreed upon and the parents cancel before the start date, a cancellation fee equivalent to one month's fee will apply as follows:

Cancellation 7 months before start: 0% fee

Cancellation 6-4 months before start: 20% of the monthly fee

Cancellation 3 months before start: 50% of the monthly fee

Cancellation less than 3 months before start: 100% of the monthly fee

During the adjustment period (first two weeks), the place can be terminated at the end of the week by either party without the two-month notice period. This is for the protection in case the arrangement doesn't work out for the parents, child, or the operation.

Data Protection Law

We work on multiple computers or laptops simultaneously and at different locations, which is why we rely on cloud services like Dropbox and OneDrive. Since these are foreign cloud services, we are in violation of the new Data Protection Act (DSG), Articles 4, Section 4 and 6, unless we have your consent. This applies particularly to a document that is uploaded to Dropbox/OneDrive and continuously worked on. We are required to maintain a detailed record of the parent and child list for the Canton of Schwyz. Parents' contact details are included, and exits are documented.

By signing the registration contract, you consent to these conditions.

For the daily recording of children's data (arrival times, meals, sleep, activities, etc.), we use the Family app. Our parents receive a login and can grant access to other family members for their child. Once the child exits the daycare, the login is deactivated, and the data is archived (as required by law).

In the Family app, we also share photos of the children's daily activities (e.g., group photos) with all parents. If parents do not wish to have internal photos shared, they must explicitly state "No" in the corresponding survey (internal photos) in the Family app. The internal photos are also used for individual children's portfolios (in printed form).

We kindly ask all parents to handle photos that include other children responsibly and to use them exclusively for personal use at home.

Care in Case of Illness

Zürisee-Krippe GmbH is not equipped to care for sick children. The decision to admit a mildly ill child is made by the daycare management on a case-by-case basis. Please refer to the information sheet: "My Sick Child and the Daycare" for the exact conditions.
